Dear Student,

Hope you & your family is safe & in the pink of health. As per directives received from the Directorate of Technical Education, M.P. Government, we were required to start all academic activities including classes in the off-line mode (which means a physical presence in the institute) from 20<sup>th</sup> Sept., 2021. This was communicated to you earlier. However, it has been observed that very few students are attending classes physically. This may perhaps be due to anxiety about your safety related to COVID-19 pandemic in your minds. We would like to remove your anxiety about safety, in view of the following preventive measures which are already in place in IPS Academy campus:

- i) All our faculty and supporting staff of the institute have been vaccinated.
- ii) All the class rooms, library, washrooms, academic area including laboratories, etc. are being sanitized regularly.
- iii) The protocols issued from various government authorities for COVID-19 pandemic are being meticulously followed as precautionary measures.
- iv) A Disaster Management Group in the institute has been constituted to monitor & combat extreme/ different circumstances due to COVID-19 pandemic that may arise in near future.

The companies which will be coming to the campus for placement purposes shall be hesitant to recruit who has not performed practical's in the laboratories. Hence, it is desirable that you perform the practical's in off-line mode (physical presence in the laboratories), so as to become an engineer in the real sense. Further, if the COVID-19 situation is under control (which is factual position, as of now), it is proposed to conduct the mid semester & end semester examinations in off-line mode, following all COVID-19 protocols. It is therefore in the interest of students to attend the classes in the institute physically, so as to prepare mind set for appearance in examinations which may be conducted in the institute premises for all students in the near future.

Considering, the implementation of COVID-19 protocols, it is proposed to conduct classes (Theory/ Practical) for all branches in engineering.

We, earnestly, once again request you to attend classes physically. You will be required to submit the certification that he/ she has been vaccinated for Corona virus and the consent from parents (format enclosed), your presence in the class either in hardcopy or softcopy at the respective e-mail
