#### **Introduction**

The IQAC meeting of the institute was held on 31<sup>st</sup> October 2020. All the members attended the meeting. The agenda of the meeting was as follows:

### 1. Confirmation of minutes of the IQAC meeting held on 19<sup>th</sup> August 2020.

The minutes of the meeting were approved unanimously by all the members.

### 2. To discuss the Academic Rules & Regulations for UG/PG programs offered by institute

The gist of the Academic Rules & Regulations for UG/PG Program offered by the institute was presented by Prof A.G Kothari, Advisor of the institute and was appreciated by all the members. After due deliberations, it was recommended as under:

#### 2.1 Structure of the Program & Curriculum

It was noted that the structure of the UG/PG program is as per AICTE model curriculum 2018 and was accepted by all.

- The total minimum credits requirement is 160 to 170 for UG and 70 for PG however the credits are fixed for each program independently by the respective BoS.
- The Choice Based Credit System proposed was accepted by all.
  - Minimum UG/ PG credits registration 16/12 (for weaker student)
  - Maximum UG/ PG credits registration 28/24 (for bright student)
- However there will be no minimum requirement for credit registration in final semester of the respective program.

#### 2.2 B. Tech. degree with Honors/ Minors certification.

It was unanimously agreed upon these additional certification courses in addition to B. Tech degree.

#### 2.3 Award of Credits & Grades

It was proposed that the Relative Grading shall be followed instead of absolute grading. All the members unanimously agreed to this proposal.

#### 2.4 Examinations

The format for question paper, the provision of reexamination after End Semester Examinations and conduct of Summer Term was accepted by the members for its implementation.

### 2.5 100% Transparency in valuation of answer sheets (CIE/ ESE)

In this respect, it was clarified that though the cases for revaluation shall reduced drastically due to showing the answer scripts, process of revaluation is being introduced for achieving 100 % transparency in evaluation.

### 2.6 Performance CGPA improvement

It was agreed that the performance CGPA improved shall be applicable even for improving the CGPA (who lost first class marginally i.e., CGPA less than 6.5), in addition to the existing scheme of RGPV for improving the CGPA less than 5.

### 3. To discuss the rules for the conduct of examinations

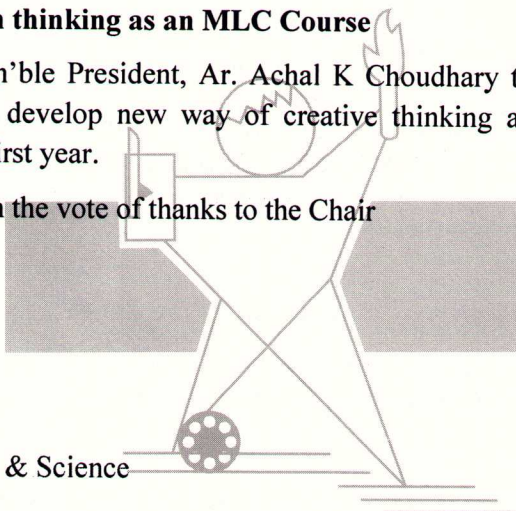

### 2. To note the progress made after implementation of the Autonomy.

The Principal gave her briefing regarding the progress made after implementation of the autonomy. The gist of her briefing is summarized as follows:

- The institute conducted its first examination in online mode on G Suite platform.
- The guidelines issued by RGPV, Bhopal were followed.
- The question papers were moderated by senior professors. In addition, there was also Head valuation after the answer scripts were valued by the examiners.
- The valued answer scripts of end sem. exams were shown to the students for complete transparency.
- The institute developed its own software related to processes involved in conduct of exams, such as, Form forwarding of the students, Computation of exam, result, etc.
- The results were declared on institute's portal after university notification.

#### 4. Increase/ reduction in approved intake of few existing programs.

It is recommended to submit the proposal to AICTE for increase/ reduction in intake of the program is as follows:

- **Increase in Intake in UG Program**  
Computer Science and Engineering (Data Science) (Intake 60 to 120)
- **Reduction in intake in UG Programs**
  - Electronics & Communication Engineering from 120 to 60
  - Electrical & Electronics Engineering from 120 to 30
  - Civil Engineering from 120 to 60
  - Mechanical Engineering from 120 to 60
  - Chemical Engineering from 60 to 30

#### 5. Addition of course in Regional Language

As per the initiative of AICTE to introduce Professional courses in Regional languages it is recommended to introduce one UG Program i.e., Computer Science and Engineering (Intake 60) in regional language

#### 6. Change in name of PG Program

- Computer Science and Engineering to Computer Science and Engineering (Artificial Intelligence and Machine Learning)
- Electronics & Communication Engineering to Digital Communication Engineering

#### 7. Twinning program


The institute shall submit the proposal to AICTE for Collaboration and Twinning Program with Indian & Foreign University for the students of the institute.

#### 8. Recognition of the institute as a PhD Research centre.

The Principal informed that the institute is in existence for last 22 years & it has enough credentials for conduct of research activities, such as, state of art laboratories, good number of faculty with PhDs & research publications in SCI/ referred journals and patents.

The members unanimously accepted the above proposal & requested the Principal to initiate further necessary action in the matter.
