NOTICE

Sub: The performance (CGPA) improvement scheme & Summer term registration for final year B. Tech. students.

As you are aware, the students of final year B. Tech. shall not be awarded a UG degree, if CGPA at end of program is less than 5. It is also possible that a student may miss first class marginally (CGPA<6.5). Such students can opt for summer term registration to improve their performance (CGPA).

- 1. Those students with CGPA less than 5 who wish to improve their performance, will be required to withdraw their grades in maximum 3 subjects (with lower grade(s)) & reregister for these subjects in the summer term and permitted to reappear in the examination for improving their grades.
- 2. The summer term shall also be offered during the summer period to facilitate the students who have missed first class marginally (CGPA<6.5). In such cases, a student shall be allowed to register for maximum of 3 subjects with lower grades and shall attend the classes regularly from Monday, 6st June 2022 in the respective departments. The students further will have to appear for internal assessment (MST-I, MST-II, Home Assignment, etc.) & ESE in these subjects.

However, the students opting for summer term shall be required to pay the additional fees per subject as decided by the Governing Body of the institute. It may be noted that the duration of summer term shall be around two months. The last date for registration for the same is Monday, 6th June 2022.

All such students are required to submit an application in the prescribed format for summer term which is scheduled to commence from Monday, 6st June 2022 to the respective Head of the Department and register for the courses in which they have been awarded poor grades.
