- To help students to be ambassadors for their institution and region.
- To foster the development of the staff of both the institutions. It will also empower faculties to achieve excellence in Teaching-Learning process.

Expected Outcomes

- Maturity and social poise, fuelled by the necessity to confront challenges outside a familiar support network and comfort zone.

Conduct of program

Finance

Duration

This MOU shall remain effective from 1st May 2022 and will terminate on 30th April 2025. However the same also may be terminated or extended with written consent.

- 2.1 To expose students to non-traditional forms of acquiring maximum knowledge in minimum time.
- 2.2 To reinforce abstract learning with learning experiences.
- 2.3 To enhance students' ability to assess and understand (in a relatively short time) the culture of new groups of people, in order to function effectively as a contributing member of the given community.
- 2.4 To expose students to the ethos of the campus environment in a different setting so as to establish bench marks against which they can measure the performance of their institution and their personal performance.
- 2.5 To observe student life in a new setting and to exchange ideas that will enrich the lives of students visiting and students in the host institute.
- 2.6 To foster staff development.
- 2.7 To help students to be ambassadors for their institution and region

3. Expected Outcomes

- 3.1 Self-development and awareness leading to enhanced self-confidence and self-esteem. This is often the most noticeable change in returned exchange students.
- 3.2 Maturity and social poise, fuelled by the necessity to confront challenges outside a familiar support network and comfort zone.
- 3.3 Integration into another family as well as the development of life-long friendships, fostering an appreciation of home and family.
- 3.4 A tremendous sense of accomplishment upon completion encourages students to develop independent opinions, make informed decisions and strive to attain fresh goals.
- 3.5 Students who go on exchange program find themselves more comfortable in any new environments.
- 3.6 Increased pressure to communicate and relate to others develops an awareness of group dynamics and personal sensitivity towards others.
- 3.7 Successful program completion represents an excellent measure of personal flexibility, encompassing an ability to reach compromise, focus and succeed through challenging times.

4. Scope

- 4.1 A student exchange program is a program in which students from different institutes visit to each other's partner institutions
- 4.2 This program can be organized in association with partner institute in any city, state or country.
- 4.3 Exchanged students can live with a host family or in a designated place such as a hostel, an apartment. Both the institutes will manage the cost and other logistic expenses during the exchange program.
- 4.4 The institute may give some credits to students for attending exchange program.
- 4.5 A short-term exchange program is also known as summer/intensive or cultural exchange program. Those focused on home stays, language skills, community service and cultural activities.
- 4.6 A short-term exchange lasts from one week to three months and doesn't require the student to study in any particular school or institution. The students are exposed to an intensive program that increases their understanding of other cultures, communities, and languages.

5. Conduct of program

Program of action for student exchange program: Every year, at least (5-10) students of both the institutes will travel to each other's institute and spend 5-10 days.

The purpose would be to learn the culture, living styles, social customs, food habits and such other aspects of the social and cultural affairs of each other's institute along with learning technical skills regarding a latest technology.

The contingent would be led by one or more teachers who will be responsible for the proper organization of the visit and also for the safety of the students. The organization of the student exchange would be done in the following manner. -

5.1 Identification of the contingent

Students in each institution may be invited to participate in exchange program. Selected faculty with in-depth- knowledge of technical subject will participate in exchange program.

5.2 Conduct of the visit

The visit will be done in accordance with the dates agreed upon by both the institutions. Since Indian Railway is expected to give concession for the movement of students, it is advised to use the Railway for movement of students to the extent possible. The visiting students can live with a host family or in a designated place such as a hostel, an apartment. The contingent will not only learn one technical skill regarding a latest technology but also interact with the local students; they would also fan out to visit historical sites and other. They would also learn the customs of the paired institute. Each of the learning process should be properly documented through photos, videos, write-ups etc. For faculty exchange program the other institute should facilitate talks of the subject expert for various groups of students.

5.3 Preparing reports

Each member of the visiting contingents is expected to focus on one aspect of the exchange program and prepare a small write-up with photographs within 30 days from the date of return from the visit.

5.4 Dissemination

The prepared report would be printed and the same would be shared to each other.

6. Finance

The cost of student visit will be borne by both the institutes (as per section 4.3)

7. Confidentiality:

At no circumstances will both institutions divulge any information which is of sanctified nature concerning their core business to any third party organization or individual or in any public forum. i.e. Student demographic Information.

8. Duration:

This MOU shall remain effective from 31st August 2021 and will terminate on 30th August 2024. However, same also may be terminated or extended by mutual written consent.
